Nevada Awards \$1.6 Million at Monthly Meeting

Carson City -- More than \$1.6 million in tax incentives was granted to four companies at the monthly meeting of the Nevada Commission on Economic Development (NCED).

Ken's Foods, Gizmo Wireless, Inc., Inta-Aussie South Pacific, and Sunterra Corporation presented their applications for sales and use tax abatements, sales and use tax deferrals, and

business tax abatement to Lt. Governor Lorraine Hunt, chair of the NCED, and six commissioners appointed by Governor Kenny Guinn. All applications were approved based on meeting NCED's mission of stimulating Nevada's economy by attracting businesses that provide high-quality jobs for its residents.
